## **Explanatory Notes**

- 2 With direction means the context for the study will be provided and general instructions for processing will be specified in writing.
- A use of science knowledge should be based on situations in keeping with curriculum content drawn from up to and including science/pūtaiao curriculum Level 6. Possible contexts are given in the curriculum documents and could be based on a technological application, a management practice, resolving an issue, or the development of a theory or model.

If a student enters for assessment against AS90187, Science 1.2 as well as any of: AS90162, Biology 1.2; AS90170, Chemistry 1.2; or AS90181, Physics 1.2, the scientific knowledge must be from different subject areas. For example, if a student is being assessed against AS90162, Biology 1.2, and is also being assessed against AS90187, Science 1.2, then the emphasis for the use of science knowledge for AS90187, Science 1.2, cannot be based on biology.

- Information for processing is to be selected from a range of sources that may be provided, which may include secondary information, ie information that has been previously collected and processed by another person. Sources of information are to be recorded in a way that can be accessed by others.
- 6 Processing information could involve listing, sorting, collating, highlighting, or summarising relevant information on science knowledge and its related use.

#### 7 Terms:

- Describe means provide characteristics of, or an account of, the scientific knowledge related to its use.
- Explain means provide reasons as to how or why the scientific knowledge applies to the use.
- Discuss means link ideas to integrate relevant scientific knowledge with its use, and will involve elaborating, justifying, relating, evaluating, comparing and contrasting, or analysing.
